RENEWAL OF THE REGISTRATION STATUS GRANTED FOR OVERSEAS MANUFACTURING PLANT UNDER THE IMPORT INSPECTION SCHEME OF SRI LANKA STANDARDS INSTITUTION -"IIL" BRAND GALVANIZED STEEL PIPES AND SOCKETS

- Every shipment of "IIL" brand Galvanized Steel pipes and Sockets shall be tested against SLS 829:2009 Specification for Galvanized Steel Pipes and Sockets and supported with quality certificates from the manufacturer with respect to different sizes/ batches as relevant.

- 4. The status of ISO 9001 certificate shall be updated on expiry, and it shall be communicated to SLSI.
- 5. If the same product/ brand is manufactured at another factory (other than the above plant address) and exported to Sri Lanka, it shall be brought to the notice of Sri Lanka Standards Institution with immediate effect.
